



1. Earnest money of successful bidder(s) will remain in custody of the office till expiry of warranty period of supplied goods.
2. The model offered must be as per the given specification including warranty or its equivalent/higher configuration and documentary evidence for the same must be enclosed.
3. The bidders should also attach their profiles with the tender.
4. The successful bidder shall supply the ordered goods within **10 days** after placing the order, at their own expenses.
5. Ordered goods must be in original sealed pack, otherwise the same will not be accepted.
6. In case the successful bidder fail to supply the ordered goods within **10 days**, his purchase order will supposed to be cancelled, earnest money will be confiscated and the order will be placed to next lowest bidder(s).
7. Income tax as applicable or announced by the Government will be deducted at source.
8. No advance payment will be permissible.
9. Quantity may be increased or decreased subject to availability of funds.
10. Bidders(s) will have to produce the proof of General Sales Tax (GST) registration.
11. The payment will be made after successful supply of all requisite items.
12. The successful bidders(s) shall provide one year warranty period and shall ensure backup support/service during warranty period at their own expenses.
