

Respectfully Sheweth:

Brief facts are as under :-

- 1) That the respondent No. 2 advertised certain post of village / neighborhood council secretaries in news paper on 11/04/2015. (Copy of the advertisement is attached as annexure "A")
- 2) That later on another advertisement was issued by respondent No.2 in continuation of the first advertisement for NTS. (Copy of the advertisement is annexure "B")
- 3) That the petitioners who belongs to Islampur and Amankot Faiz Abad Union Councils, along with many others candidates applied for the posts and participated in the NTS. (CVs of the petitioners are annexure "C" and may be considered as integral part of this petition.

- 4) That after passing the NTS, the petitioners and other successful candidates were called for interviews on 20/12/2015. (Copy of the NTS result is attached as annexure "D")

- 6) That prior to the appointments of respondents Nos. 33 to 81 an illegal, unlawful, void ab-initio adjustment / transfer order of respondents Nos. 6 to 32 was issued mala-fiddly in order to deprive the petitioners from their legal and vested right of appointment in their respective native village council / neighborhood council etc. (Copy of the adjustment / transfer order of respondents Nos. 6 to 32 along with the letter No. Director (LG) 3-1/ Establishment / 2013/3401 dated Peshawar, the

Grounds:

- a. That at the time of the issuance of the above mentioned transfer / adjustment order, there ~~were no surplus pool staff in District Swat, which~~ was a pre - requisite for the adjustment / transfer order as mentioned in the letter No. Director (LG) 3-1/ Establishment / 2013/3401 dated Peshawar, the 26<sup>th</sup> June, 2015.

c. That the impugned adjustment / transfer and appointment orders are in gross violation of the letter No. Director (LG) 3-1/ Establishment / 2013/3401 dated Peshawar, the 26<sup>th</sup> June, 2015 and the conditions mentioned in the above advertisements, which are already annexures "A&B".

d. That the impugned transfer / adjustment order along with the new appointment orders of respondents Nos. 6 to 81 are arbitrary, capricious. These orders are issued by officials

This fact can be very easily detected from the record that the petitioners score was high then the blue eyed in the NTS Test, but they were awarded lesser marks in interview deliberately.

g. That other grounds will be raised at the time of arguments with the prior permission of this august Court.

Any other relief which this august court deems fit and necessary may also be granted in the given circumstances of the case.




