**WRIT PETITION UNDER ARTICLE 199 OF THE CONSTITUTION OF  
ISLAMIC REPUBLIC OF PAKISTAN 1973 AS AMENDED UPTO DATE.**

**Respectfully Sheweth:**

**FACTS:**

1. That the petitioner is a bonafide Resident of village Baghicha Kalay V/C Kharky Dheri U/C Sakhakot Jaded. Copy of CNIC is annexed as (A).
2. That the District Education Officer (M) Malakand advertised various Posts including PST. Advertisement is annexed as (B). Where in all the conditions were published.  
It is pertinent to mention here that according to **Condition No 01**, the PST Posts were on U/C Base.
3. That the petitioner being a Resident of V/C Kharki Dheri U/C Sakhakot (Jaded) took part in the test conducted by ETEA, got 121.45 marks and stood at serial NO:14 in the Merit List of UC Concerned. Then one Mr. Muhammad Faisal S/O Muhammad Amin at Serial No.6 (**REFUSED**) the post due to his Probable selection as (**SCHOOL LEADER**) and the petitioner stood at serial No.13 of the merit list. M/List is annexed as(C).
4. That the total vacant PST Posts in the UC were also 13.
5. That the Petitioner was hopeful for his appointment but the order issued on 22-09-2022, only (09) candidates were appointed. Then on 29-09-2022 another order of (02) candidates was issued and then on 18-10-2022 a third order of (01) candidate was issued. The total number of appointees were (12). Now the petitioner was entitled for appointment due to his merit. But one Mr.Esa Aziz R/O U/C Dargai was appointed at GPS Mayar (Petaw) at U/C Sakhakot Jadeed with the reason best known to the (DSC).  
All the concerned pages of the mentioned (04) appointment orders are annexed as D, E, F, G.
6. That the petitioner submitted an Appeal to Respondent No: 3 but no response were made in this regard. Appeal is annexed as (D).

**GROUNDS:**

- A. That the action and inaction of the Respondents by not appointing the petitioner, as PST with clear merit position, is against the law, rule, fact, norms of natural justice.
- B. That the petitioner has not been treated by the Respondent Department in accordance with law and rules on the subject noted above and as such the Respondents violated the Laws lays down by the constitution of Islamic Republic of Pakistan 1973.
- C. That the treatment meted out to the petitioner is a clear violation of the fundamental rights of the petitioner as enshrined in the constitution of Pakistan 1973.
- D. That the petitioner has been discriminated by the Respondents on the subject noted above and as such the Respondents violated the Principle of natural justice.
- E. That the petitioner seeks permission of this Hon'ble Court to advance other Grounds and proofs at the time of hearing.

**PRAYER**

It is therefore, most humbly prayed that on acceptance of this **WRIT PETITION**, the respondents may kindly be directed to appoint the petitioner as PST at GPS Mayar where his right is reserved according to his merit and total number of vacant positions.

**INTERIM RELIEF**

It is also requested that the Respondents may please be directed to suspend the operation of the Appointment order to the extent of Private Respondent No: 5 till the Decision of the instant WRIT PETITION.

Any other remedy which this August Court deems appropriate may kindly be awarded to meet the ends of justice.



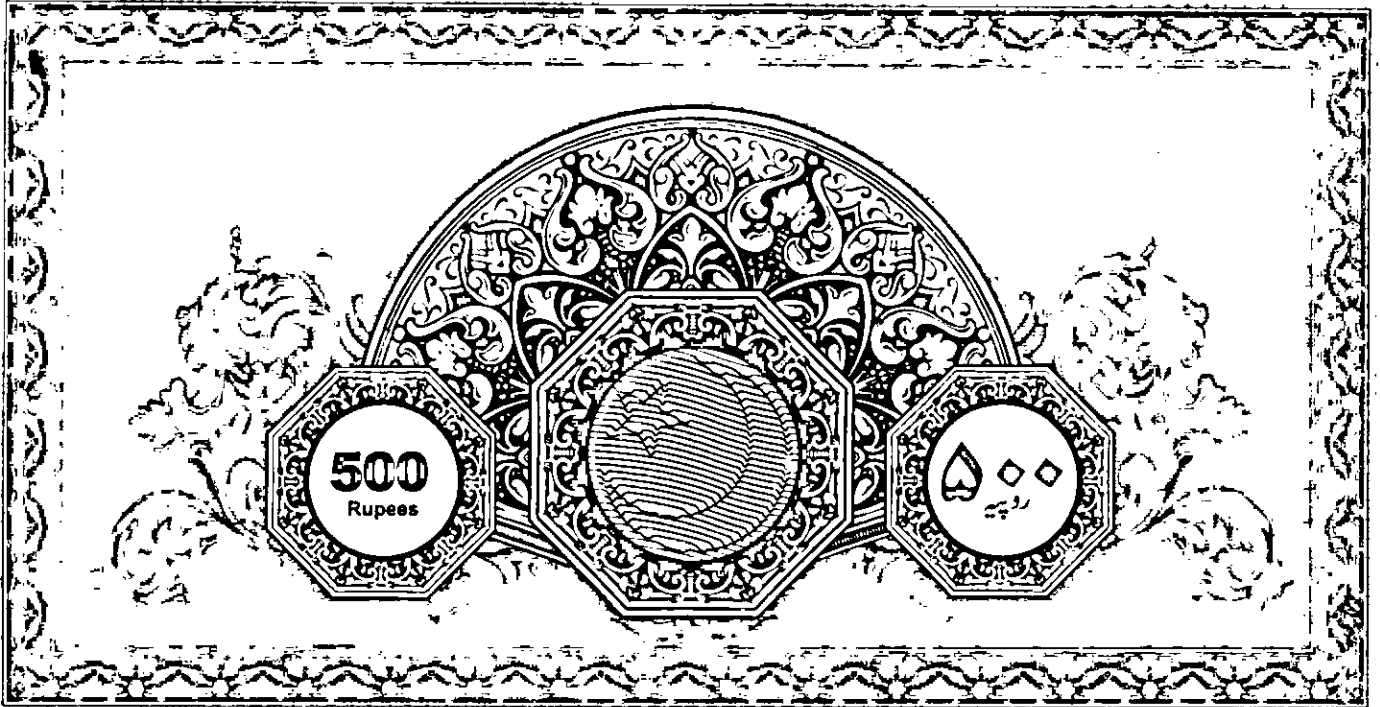

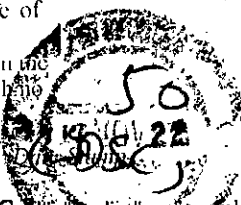
